**CONCESSION FOR USE OF THE PUBLIC ASSET for purposes of exploiting the ZOO, the BOTANIC GARDEN and the FARM, comprising management, environmental education, recreational, leisure, cultural and ecotourism activities along with their related services, as approved by the Legislative Branch of the State of São Paulo, through State Law no. 17.107 of July 4, 2019.**

### TERM OF DELIVERY OF THE PUBLIC ASSET

Under the terms of item V of Clause 5.5 of Concession Contract no. [•], on one hand, the State of São Paulo, as the GRANTING AUTHORITY, by means of the STATE SECRETARIAT FOR INFRASTRUCTURE AND ENVIRONMENT, herein represented by its [•], Mr. [•], bearer of RG (ID number) no. [•] - [•], registered at the CPF/ME (Individual Taxpayers Registration) under no. [•], establish, as of 00:00 a.m. on [•] of [•] of [•], the TERM OF DELIVERY OF THE PUBLIC ASSET, pursuant to ANNEX I of Concession Contract no. [•], comprising the territorial plot included within the confines of the State Park Ipiranga Springs, and by the FARM's grounds located in the municipality of Araçoiaba da Serra, both according to the perimeter described and further detailed in ANNEX I.

Execution of this TERM OF DELIVERY OF THE PUBLIC ASSET is a requirement for this CONTRACT to come into full force and effect, and took place within the period of [•] days, effective the DATE OF EXECUTION of the CONTRACT.

The CONCESSIONAIRE was granted access to the CONCESSION AREA during the time frame ranging from the DATE OF EXECUTION of the CONTRACT to the date of signing of this TERM OF DELIVERY OF THE PUBLIC ASSET, to oversee the delivery of the asset as well as to devise a photographic report along with a descriptive memorandum of all current facilities, equipment, assets, and building projects in the CONCESSION AREA, enclosed in this TERM OF DELIVERY OF THE PUBLIC ASSET.

The GRANTING AUTHORITY's approval of the photographic report and descriptive memorandum, as well as the signing of the TERM OF DELIVERY OF THE PUBLIC ASSET, shall entail the direct transfer of ownership of current facilities and equipment in the CONCESSION AREA, except for assets or equipment whose ownership may potentially not be transferred to the CONCESSIONAIRE, pursuant to the terms of ANNEXES II and III, to the CONCESSIONAIRE, regardless of this taking place prior to the transfer of the BIOLOGICAL ASSETS. The CONCESSIONAIRE shall be liable for upkeep and preserving all facilities and equipment transferred due to the signing of this TERM OF DELIVERY OF THE PUBLIC ASSET.
